Connextion meets: Dr. David J Bennett

Dr David J Bennett will be one of the moderators at the forthcoming EU Hitachi Science & Technology Forum. He has a PhD in biochemical genetics and an MA in science policy studies, with long term interests in the relations between science, industry, government, education, law, the public and the media. He has worked in universities and industry in the UK, USA, and Australia and is now in the Netherlands. A member of numerous national and international organisations and committees in biotechnology, he works for the European Federation of Biotechnology (EFB) and the European Commission. Especially in relation to this Forum, he is Secretary of the EFB Task Group on Public Perceptions of Biotechnology and its Section on Education in Biotechnology.

Connextion: Could you give us a brief overview of Life Sciences in Europe?

Dr. Bennett: "Life Sciences are one of the most rapidly developing areas of science and technology and one with major impact on the every-day lives of people and societies. This has now begun with the introduction of new pharmaceutical products such as vaccines and diagnostics and new crop varieties and foods made with the use of genetic modification. While healthcare applications are generally welcome, and very much sought by sufferers of many diseases, especially of genetic disabilities, HIV, malaria, etc., applications in agriculture and food production raise widespread concerns about human and environmental safety and ethical considerations. These have been taken up by activist groups and the media, both with their own interests and agendas, leading to delays in the approval of genetically modified food products and their introduction to the market in Europe. This has resulted in the withdrawal from sale of already-marketed products containing genetically modified ingredients together with the holding back of many new products from the market. Yet it is crucial that Europe maintains its competitive position in the undoubted global development of these technologies. Otherwise it will lose the employment opportunities and economic returns (which sustain its social systems) from them, together with the investment in research and development already made, and again become largely an importer of the technologies and products, as has already happened with other areas of technology. For Europe, it is a case of "use it or lose it."

Connextion: What do you think about the Forum programme?

Dr. Bennett: "The EU Hitachi Science and Technology Forum takes an expert look at life sciences in European society, today and for the future. It will be introduced by speakers who are among the people with the greatest experience in the world of life sciences policy, followed by top level scientists and industrialists giving state-of-the art accounts of four main areas of life sciences: healthcare, agricultural and food applications, and in relation to the environment. Debate about their impact on European society will be initiated by a distinguished science journalist. Forum members will then have the opportunity to discuss what
